

List of Constitutional Amendments Proposed at the 2026 General Meeting of the Ontario PC Party

<p><u>Amendment #1 (Constitution Committee) - Remove Reference to Facsimile (Fax) Notice</u></p> <p>ARTICLE 1 – DEFINITIONS</p> <p>Delete the red underlined language and insert the blue underlined language:</p> <p>1.1 (n) "Notice given in writing" means delivery by mail, hand or electronic mail (email), <u>unless the recipient has agreed that facsimile (fax) notice is preferred and/or acceptable.</u></p>	<p>Amending Article 1 Section 1 by deleting a sentence</p>
<p><u>Amendment #2 (Constitution Committee) – Remove references to clubs, including the PC Blue Club and PC Business Club:</u></p> <p>Delete the red underlined language from the Constitution and insert the blue underlined language:</p> <p>ARTICLE 1 – DEFINITIONS</p> <p>1.1 (s) "Recognized Association" means ... <u>Club</u> <u>club</u> or any other association of the Party pursuant to Article 4 herein.</p> <p>ARTICLE 4 – RECOGNITION</p> <p>4.1 (d) <u>The PC Blue Club and PC Business Club, as they were recognized by the Executive on February 11, 1989. No additional clubs shall be recognized. Should the PC Blue Club or the PC Business Club cease to exist as recognized, this subparagraph is automatically amended by deleting the reference to the club.</u></p> <p>4.2 In each of the cases described in paragraph 4.1 above, "Recognition" shall be extended to and maintained by only those Riding Associations, District Associations, Women's Associations, Youth Associations, Campus Associations <u>and Clubs</u> which have submitted to their respective Provincial Associations ...</p> <p>ARTICLE 5 – RECOGNIZED ASSOCIATIONS</p> <p>5.1 (a) Any person who has attained the age of fourteen (14) years, who supports the Statement of Principles and the Objects of the Constitution and of the constitution of the recognized Association, shall be entitled to be a member of the Association upon payment of the fee set pursuant to Article 7 and, in the case of a Women's Association, Youth Association, <u>or</u> Campus Association <u>or Club</u>, compliance with the membership provisions of the Association constitution.</p> <p>ARTICLE 10 – DUTIES OF OFFICERS</p> <p>10.5 (g) The Treasurer shall cause a quarterly information letter on the finances of the Party to be distributed within four (4) months of each of the first three quarters of the Party's financial year to the executive members of the Provincial Associations, to the Presidents and Chief Financial Officers of the Riding Associations <u>and recognized party clubs</u> and to any other person designated by the Executive.</p> <p>ARTICLE 17 – DELEGATES TO SPECIAL GENERAL AND GENERAL MEETINGS</p> <p>17.2 <u>(l) Four (4) delegates from each recognized Party club.</u></p>	<p>Amending Article 1, Article 4, Article 5, Article 10, Article 17 by deleting the red underlined language and inserting the blue underlined language</p>
<p><u>Amendment #3 - Amend Article 7 (Membership) and Article 8 (Member Recruitment System and Provincial Party Membership Registry):</u></p> <p>7.1 <i>Membership in the Party shall be open to persons of fourteen (14) years of age or over, without regard to race, origin, religion or sex. Members must be residents of Ontario and uphold this Constitution.</i></p> <p>7.2 <i>A member of the Party is any person who is a member of a Recognized Association.</i></p> <p>7.3 <i>Fees for membership in all Recognized Associations shall be set <u>by the respective executives of such Associations, subject to rules made</u> by the Party Executive.</i></p> <p>7.4 <i>Membership in a Recognized Association may be acquired,</i> <i>(a) by application directly to the Association; or</i> <i>(b) through the Member Recruitment System</i></p>	<p>Amending Article 7, Article 8, by deleting the red underlined language and inserting the blue underlined language</p>

7.5 Payments of a membership shall be done by personal cheque or credit card, the foregoing which may include payment on behalf of family members of the same household. Payment of a membership by cash, corporate cheque, or corporate credit card shall not be permitted.

7.6 A member of the Party shall not concurrently be a member of another provincial political party in Ontario. Any person who holds a membership in another provincial political party in Ontario shall have their membership in the Party automatically revoked.

7.7 Members need to abide by the Code of Conduct

ARTICLE 8 MEMBERSHIP RECRUITMENT SYSTEM AND POLITICAL PARTY MEMBERSHIP

REGISTRATION

8.1 The purpose of the Member Recruitment System is to encourage and facilitate the recruitment of new members in a manner that respects the role of Recognized Associations.

8.2 The Provincial Party Membership Registry is the official record of members of the Party.

8.3 At least once per month, the Secretary shall provide to Recognized Associations the names, addresses and allocated fees related to memberships sold through the Member Recruitment System.

8.4 Each Recognized Association shall report regularly to the Secretary the memberships acquired directly by application to the Association.

8.5 Subject to eligibility and compliance with this Constitution and the rules, membership takes effect when the application and fee are received.

(a) by a Recognized Association, in the case of membership acquired through the association; or

(b) by the Secretary, in the case of membership acquired through the Member Recruitment System.

8.6 All memberships, whether acquired through Recognized Associations or through the Member Recruitment System, shall be recorded on the Registry.

8.7 As a confidential asset of the Party, neither the Membership Registry, nor and part or portion of it, shall not be sold or made available to any person or organization outside of the Party.

8.8 The Party Executive may make rules,

(a) regulating membership fees;

governing the application, recruitment, membership and registry processes, including rules that prescribe forms or require timely communication of corrections or changes to membership information;

(b) governing membership renewal;

(c) setting deadlines for taking steps referred to in Articles 7 and 8 or related to the administration of Articles 7 and 8;

(d) respecting challenges to applications and the means of authenticating eligibility;

(e) related to residence;

(f) related to proof of membership, including rules that provide for standard membership cards;

(g) respecting the transfer of membership upon change of residence; and

(h) governing the use of the registry.

Amendment #4 (MPP Caroline Murlone) - Designate one of the numbered Vice-President positions as a Francophone position:

Whereas

Franco-Ontarians are part of the Ontario PC Coalition;

The Ontario PC Party recognizes the significant contributions of Franco-Ontarians to the cultural, social and economic life of Ontario.

Franco-Ontarians are one of the founding peoples of Ontario and Canada;

The constitution of the Ontario PC Party should also reflect Francophones on the Ontario PC Executive Council;

Be it resolved that the Ontario PC Party designate one of the numbered Vice President positions to be designated for a Francophone member of the Ontario PC Party to represent Franco-Ontarians as a member of the PC Executive.

Attendu que

Les Franco-Ontariennes et les Franco-Ontariens font pleinement partie de la coalition Ontario PC;

Le parti Ontario PC reconnaît les apports significatifs des Franco-Ontariennes et les Franco-Ontariens à la vie culturelle, sociale et économique de la province;

Amending Article 9 by inserting blue underlined language.

Par conséquent, qu'il soit résolu que l'un des postes de vice-présidence du parti Ontario PC soit réservé à un membre francophone, afin de représenter les Franco-Ontariennes et les Franco-Ontariens au sein du Conseil exécutif.

9.2 (d) Nine (9) Vice-Presidents provided that; the 2nd shall be a Francophone; the 4th and 7th shall be men the 5th and 8th shall be women; and the 6th and 9th shall be eligible to be members of the Youth Association.
